INSTRUCTIONS TREE & LANDSCAPE PLAN REVIEW

- 1. Complete the application form and return it to the Building & Development Department, 2751 S.H. 35 Bypass, Rockport, TX 78382 along with the required filling fee of \$50.00 plus \$20.00 per acre. (Section 22-315, Rockport Code of Ordinances).
- 2. The application shall include:
 - any drawings showing the site in question indicating all boundaries and existing structures if any;
 - ii. location and size (diameter) of all trees (protected and windswept);
 - iii. indication of those trees to be removed, relocated or new plantings;
 - iv. indicate proposed landscaping plan along with point count pursuant to Section 106-33, Rockport Code of Ordinances; and
 - v. indicate all proposed improvements (buildings, parking, driveways, dumpsters, etc.)
- 3. The applicant or applicant's representative will be notified to meet for consultation and be advised of the hearing date with the Rockport Tree & Landscape Committee. By law, the Tree & Landscape committee's agenda must be posted at least seventy-two hours (three days) prior to the meeting.
- 4. We recommend that the applicant or applicant's representative be present at the hearing with the Tree & Landscape committee to answer any questions that might arise.

CITY OF ROCKPORT TREE AND LANDSCAPE PERMITS AND PLAN REVIEW:



- Application for Brush Clearing Permit:
 - Needed for clearing trees/brush less than 8" DBH
 - \$25 Permit Fee
- ❖ Application for Tree Trimming/Removal Permit:
 - Needed if separate from new construction building permit
 - Needed if removing any tree 8"+ DBH (see exceptions on pg.1, but permit required)
 - \$50 Permit Fee
 - Remember no mitigation fees on trees < 10" Single Family Dwellings (R-1 & R-2)
 - On the permit, include size (DBH) and species of tree(s) to be removed. If possible, include a drawing showing location of tree(s) to be removed.
 - Needed for trimming trees. No more than 25% of tree canopy can be removed.
- Application for Tree & Landscape Plan Review:
 - Needed for new construction (residential or commercial) if separate from building permit. Or prior to building permit for larger projects that require approval from the Tree and Landscape Committee first.
 - Provide a Site Plan/Tree Mitigation Plan showing trees to be removed and tree
 points that count toward replanting mitigation and/or \$50/inch into the Tree
 Preservation and Mitigation Account.
 - In addition to the Landscape Plan showing all proposed trees and existing trees 6"+ DBH (and landscape points for new plantings as required in Ch.106-33); provide a Tree Mitigation Plan (mentioned above) to include a chart showing total inches of 8"+ trees on site; total inches of trees to be removed; total inches of trees to be preserved; and mitigation inches needed. Mitigation inches needed can be planted onsite and/or paid into the Tree Preservation and Mitigation Account if not feasible to plant onsite.
 - Remember that: Protected trees (8"-24"DBH) mitigate at a ratio of 1": 1"
 Century trees (24"-48"DBH) mitigate at a ratio of 1": 3"
 Heritage trees (48"+DBH) & Windswept mitigate at a ratio of 1": 5"

CITY OF ROCKPORT TREE AND LANDSCAPE PERMITS AND PLAN REVIEW:



- Continued Application for Tree & Landscape Plan Review:
 - Credit can go towards preserved trees:

Protected trees (8"-24"DBH) - credit at a ratio of 1": 1" Century & Heritage trees (24"-48"+DBH) – credit at a ratio of 1": 3" Windswept trees - credit at a ratio of 1": 5"

- Summary for larger projects:
 - Need to get approval by the Tree and Landscape Committee first.
 - If Landscape Plan and Tree Mitigation Plan are approved by the T&L, then submit application for Building Permit with approved Tree Plan.
 - If tree and brush removal are necessary prior to issuance of Building Permit, submit Application for Brush Clearing Permit with approved Tree Plan.
